

# **Synod Council Meeting Minutes**

Vitality Report; Director of Administration and Events Report; and the Director of Communication Report. When the council came back from the chat rooms each group gave a brief report on what stood out from the report they were assigned to discuss.

#### Treasurer's Report

Mr. Erik Rehms led a review of the current financial statements showing very good results for the first nine months of the fiscal year.

MSP SC21.12.04 to accept the Treasurer's Report dated October 31, 2021, with an increase in total assets of \$399,274.

### **Congregations in Transition**

Synod staff has been busy keeping up with recent installations. There are two upcoming ordinations on the calendar.

Deacon Janice L. Zimbelman has accepted the call to be Director of Congregation Transitions for the Rocky Mountain and Grand Canyon Synods. Because of this, a new transition coach will be needed for the GCS.

Alleluia Lutheran Church and Christ Evangelical Lutheran Church in Arizona and The Lakes and Good Samaritan Lutheran Churches in Nevada are working on merger plans. Living Christ Lutheran Church, Flagstaff, Arizona has sold its property and will be relocating to another ministry site.

### Strategic Discussion and Updates

Synod Administration of Celebration Lutheran Church, Peoria, AZ

The sale of the property will likely close in January 2022. Ms. Twila Burdick reported that Ms. Theresa Thornburgh is assisting with the administrative and archival issues involved in this closure and sale. The trustees have all worked very hard to assure this process has moved forward with grace. Future discussion will be on how to best use these resources for new ministries and opportunities.

Lutheran Campus Ministry

The Rev. Jacqui Pagel reported that Cantebury (Episcopal Church – USA) and Lutheran Campus Ministry, Flagstaff (LCMF) are working together and

are staffed by a lay person from each church body. Rev. Pagel and her counterpart in the EC-USA recommend moving towards a common staffing with one ordained person serving the common ministry of both LCMF and Cantebury. This recommendation has been communicated to the board and they are working on a four-year plan to assure this happens.

Lutheran Campus Ministry, University of Arizona, Tucson, AZ is moving to the Our Savior Lutheran Church, Tucson, AZ campus. Ministry is going very well at the Lutheran Campus Ministry in Tempe, AZ at Arizona State University.

Growing Generosity Campaign Update

The campaign has exceeded its goal for this point in its plan and is just short of raising \$485,000. The leadership team of the campaign is planning an abundance goal in the event the campaign exceeds its \$500,000 goal. The leadership team is so grateful for how the Holy Spirit is leading people and congregations to be generous.

Stewardship for All Seasons was lifted up as an example of how the appeal was making a difference throughout the GCS.

#### **New Business**

Synod Call

MSP SC21.12.07 to issue a synod call to the Rev. Mark D. Wickstrom to serve as part-time interim pastor of The Lakes Lutheran Church, Las Vegas, NV effective October 5, 2021.

Supply Pastor Compensation

MSP SC21.12.08 to set the supply pastor stipend rate to \$200.00 plus \$50.00 for each additional worship service led over a weekend with mileage reimbursed at the current IRS rate and overnight accommodations provided if overnight travel is necessary.

### **Grants Report**

The synod council was updated on the grant process for 2021. The committee was impressed with the passion for mission which congregations have expressed during this particular cycle with its many challenges.

Moving into the 2022 grant cycle, the webinar that was introduced this year will continue along with other ways to inspire innovation as priorities change as we lean into a post-pandemic world.

#### **Concluding Discussion**

The Synod Council went into breakout rooms to discuss and process the meeting asking, "What stood out to you during this packed meeting?" The council reconvened out of the breakout rooms for a time of sharing. Highlights were: the abundance of healthy conversations and generosity; a concern for ministries that have used PPP loans to survive; and, thanksgiving for a synod staff that makes things look easy.
