#### Call to Order

With a quorum present Mr. Paul Gryniewicz called the meeting to order at 10:00 A.M.

#### Welcome and Introductions

Bishop Deborah Hutterer led a time of welcome and introductions.

#### Grounded in the Word

Bishop Deborah Hutterer read from Colossians 3:16, "Let the word of Christ dwell in you richly; teach and admonish one another in all wisdom; and with gratitude in your hearts sing psalms, hymns, and spiritual songs to God."

Looking at this verse from a leadership perspective Bishop Deborah Hutterer was reminded of a survey of those who had stepped away from church leadership. These leaders all reported that they had hoped leadership in the body of Christ would have deepened their level of spirituality, but the experience of church leadership did not, and this was a disappointment.

Bishop Deborah Hutterer suggested that as synod leaders we commit to being prayer partners with one another. The council decided to be divided up into pairs for the purposes of supporting one another through prayer.

#### Adoption of Agenda

#### Minutes

#### **Approval of Roster Changes**

The Rev. David Brandfass moved MSP SC19.09.04 to change the ELCA roster status of Rev. Paul E. Hansen from On Leave from Call to Retired effective December 1, 2019.

#### The Rev. David Brandfass moved

MSP SC19.09.05 to issue a synodical call to The Rev. Kevin J. Meyer to serve at Lutheran Social Services of the Southwest effective August 1, 2019.

The Rev. Tina Mills moved

MSP SC19.09.06 to change the ELCA roster status of The Rev. Cesar Abel Arroyo Traverso from active status to disability status effective May 26, 2019.

#### Strategic Discussion and Action

Treasurer's Report

Mr. Erik Rehms presented the Treasurer's Report through July 31, 2019. The report was reviewed by the Synod Council and is attached to these minutes as **Exhibit 1**.

Mr. Erik Rehms noted that we are in transition in the Treasurer's area. This report was written by Mr. Jerry Zaddack, whose term ended on August 31, 2019. The reports presented are through July 31, 2019. The most significant change on the balance sheet is due to the sale of the synod owned property on 4901 W. Indian School Road, Phoenix, Arizona. In the area of income, congregational mission support is nine percent above the budgeted amount.

Bishop Deborah Hutterer reported that the follow up thank you calls to congregations for their mission support have been a delight.

#### The Rev. David Brandfass moved

MSP SC19.09.07 to approve, as presented, the Treasurer's Report showing synod finances as of July 31, 2019.

#### Funds and Descriptions

Mr. Erik Rehms reported on the work done to clarify and consolidate the funds that the synod manages for the purpose of supporting the mission of the Grand Canyon Synod. The proposed schedule of consolidated funds is attached to these minutes as **Exhibit 2.** 

### The Rev. David Brandfass moved MSP SC19.09.08 to accept the recommendation of the GCS Financial Task Force in regard to funds and description of funds.

#### Iglesia Luterana Vida Nueva

Ms. Barbara Carl updated the Synod Council on discussions with the leadership at Iglesia Luterana Vida Nueva (Vida Nueva), Glendale, AZ on improving the relationship with the Grand Canyon Synod. It was clear that the Vida Nueva congregation sees the Vida Nueva Fund as designated to support their congregation. The congregation was unclear if they were under synodical administration, though the time period for that administration expired February 28, 2019.

#### The Rev. David Brandfass moved

MSP SC19.09.09 to recognize that effective February 28, 2019 that Iglesia Luterana Vida Nueva, Glendale, Arizona is no longer under synodical administration.

Due to the amount of misunderstanding between Vida Nueva and the GCS, Bishop Deborah Hutterer requested that the Synod Council prays for continued healing as the Grand Canyon Synod and Vida Nueva move forward in a positive way as church together.

Sale of 4901 W. Indian School Road Property

Following the closure of Concordia Lutheran Church, Phoenix, AZ the property Concordia owned at 4901 W Indian School Road became the property of the Grand Canyon Synod and has now been sold. Vida Nueva, which had temporarily occupied this site through an agreement with the synod, has moved to St. John's Lutheran Church, Glendale, AZ.

### The Executive Committee moved

MSP SC19.09.10 to allocate the funds from the sale of the Grand Canyon Synod owned property at 4901 W Indian School Road as follows: 1. To tithe ten percent of the amount received from the sale to the Evangelical Lutheran Church in America; 2. To reserve \$150,000 for future Lily Grant matching funds, but if not spent within three years for the Lily Grant, then move this reserve to a fund designated by the Synod Council at that time; and, 3. To designate the remaining balance of the 4901 W Indian School Road

# Fund to the Outreach Fund, thereby closing out the 4901 W Indian School Road Fund.

#### Information

#### Synod Council Documents

The synod staff was thanked for getting the Synod Council agenda materials to the Synod Council members well in advance of the meeting. Different options for disseminating the materials in an efficient way were discussed.

#### Update on 2020 Grant Process

The current process is underway, and documents are available on the GCS website.

#### Congregations in Transition

Bishop Deborah Hutterer reported on the list of seventeen congregations in transition in the GCS. There is one other known congregation that will soon be in transition.

#### Churchwide Assembly Actions

Bishop Deborah Hutterer gave an overview of the decisions of the Churchwide Assembly (CWA) held August 5-10, 2019 in Milwaukee, Wisconsin. Highlights of the CWA included the celebration of fifty years of Lutheran women being ordained in the United States, forty years of women of color being ordained, and ten years of LGBTQIA+ individuals being able to serve freely in the ELCA. The CWA passed many important resolutions and documents including the social statement titled "Faith, Sexism and Justice: One in Christ;" a policy statement titled, "A Declaration of Inter-Religious Commitment," and the documented titled "A Strategy Toward Authentic Diversity within the ELCA."

Notably for the GCS, The Rev. Karn S. Carroll was elected to a term on the ELCA Church Council.

Mr. Paul Gryniewicz provided an overview of the process that led to the declaration of the ELCA as a "Sanctuary Denomination" with discussion held on how being a "Sanctuary Denomination" has been received around the Grand Canyon Synod.

#### **New Business**

Lilly Endowment Grant Proposal

The Synod Council was informed about a grant application in process with the Lilly Endowment. This grant application is being made in collaboration the Rocky Mountain and North Carolina Synods. The Grand Canyon Synod makes up the third member of the collaboration. This is a matching grant application, so if the GCS can raise \$150,000 we would receive another \$150,000 from the Lilly Endowment. One of the most exciting parts of this grant is a program titled "Stewardship for All Seasons" (SAS). GCS committed that a minimum of 5 congregations would join the first cohort of SAS. Bishop Hutterer and Pastor Miguel will recruit and invite participation.

Review of Synod Council Responsibilities

Bishop Deborah Hutterer reviewed the GCS Constitutional provisions that guide the work of the Synod Council. The members and role of the Executive Committee were also reviewed.

Treasurer's report for August 28, 2019 Executive Committee Meeting – Jerry Zaddack

Comments regarding Financial Statements as of July 31, 2019 -

- Operating cash = \$708,834 nearly unchanged from June. The increase from Fiscal Year Ended January 31, 2019 was primarily due to several special gifts.
- Mission MIF accounts had a large increase due to the \$542,567 of proceeds from the sale of the property. The Buildings and Land on the Balance Sheet decreased to zero from \$724,700 also due to the sale of the Indian School property.
- Please note when the Indian School property was acquired by the Synod, for some unknown reason, the Financial Director did not add this asset to the Synod's balance sheet. When Clint recognized this error earlier this year, he added the property to our balance sheet as an asset at \$724,700 which was the Assessed Value at the time the Synod acquired the building in July 2016. The Synod is exempt from paying property taxes, so the assessed value had no effect on the Synod's operating expenses. In January 2019 we obtained a Broker's Opinion of value which stated the broker's opinion of value was \$591,848 as of January 16, 2019. July 2019, we sold the property for \$600,000. After subtracting sales commissions, closing costs and a credit to the buyer for repairs identified by the property inspector, the net proceeds from the sale were \$542,567. Thus, on paper the balance sheet shows a decrease in net assets from the sale of the Indian School Property, but this is simply a paper loss.
- The Statement of Activities on page 2 shows a net year-to-date **increase** in net assets of \$113,424 as compared to a budgeted YTD loss of \$102,858, which resulted in net positive variance of \$216,292. However, there was a \$161,310 loss for the month of July primarily due to the \$147,740 non-cash loss on the sale of the property. This property has been on our books for less than a year. If it wasn't for this non-cash loss, July would have been an average month with a relatively small loss.
- Our revenue results for July increased our YTD positive variance of \$287,665 by about \$18,000 over June.
- Our total YTD expenses of \$1,270,762 were significantly over budget by \$184,540 primarily due to this non-cash loss on sale of the property.

PLEDGE TO ACTUAL (Through July 31, 2019) - Not included in financial statements

- Through July, Unrestricted Mission Support Revenue is \$948,226 is \$19,225 (11.8%) higher than our planned Unrestricted Mission Support revenue of \$870,316.
- 58 of the 89 congregations gave in July and overall GCS gifts are \$58,534 higher than last year at this time and \$77,909 ahead of this year's budget.
- Forty-nine (49) congregations have met or are ahead on their pledge.
- Only seven (7) of the 89 congregations (8%) haven't given any Mission Support for the year.
- Forty (40) of the 89 congregations (45%) are behind on their pledge with 31 congregations behind 10% or more. Collectively, these 31 congregations are behind \$89,952. However, only a six (6) congregations are behind by \$5,000 or more.




